motto: "peace a word. ONLY one word?" (composition, Nikolaus Fheodoroff, 1987)

The Province of Carinthia invites, according to the Carinthian Culture Promotion Act of 2001, LGBI. Nr. 45/2001 idgF., entries for a competition in the

category: • VOCAL / INSTRUMENTAL MUSIC

for: large mixed choir (at least 48) and large orchestra (to 4-fold wood, brass, (max.) 3 drummers, string orchestra) for the 4. International Nikolaus Fheodoroff Composition Prize.

We are looking for a composition with a spatial division of the orchestra (optionally also the choir). As the amateur choirs are numerous in Carinthia, the parts for mixed choirs must be performable. The venue will be a large hall (Messehalle) in Carinthia.

duration: • 20 to 25 minutes.

The prize carries a value of \in 10,000. An independent jury will normally award the prize to one entrant; in exceptional cases, the prize may be divided between two or more entrants, provided that this meets with the technical requirements of the respective categories.

The Prize will be awarded in 2019. A world first performance of the prize-winning work is planned at the 50 years anniversary of the Carinthian Summer Music Festival 2019. The submitted work must be unpublished.

Composers wishing to enter a work for the prize should submit the following documents:

- a) completed entry form (1 copy)
- b) artistic curriculum vitae (1copy)
- c) a work (world first performance) in the category announced (8 copies).
- Composers of all ages and nationalities are eligible to enter.
- Each entrant may submit only one work.
- Works which do not comply with the conditions of entry will not be considered for the prize.
- No liability or responsibility can be assumed for loss, damage or destruction of original documents submitted for the competition.
- Please note that detailed reasons for the jury's decision will not be given.
- Should the jury so decide unanimously, the Nikolaus Fheodoroff Composition Prize may not be awarded.
- Entrants guarantee that any texts which are used in the works submitted or serve as a basis thereof are either in the public domain, or if still protected, used with written permission from the author or author's representative (publisher or estate), thereby indemnifying and holding harmless the Province of Carinthia.
- Prize-winners are responsible for any tax due on prize money
